

The same motion was carried with a Vote 26 in favor, 00 opposed and 2 abstained.

Patricia Uentillie mentioned they live five miles out and reported who ever graded the road did an awful job, the road towards Greasewood. The Apache County staff responded that culverts are used if it is needed and he reported that the Greasewood Road is maintained by NDOT.
