8. Clarence Chee commented that all the projects mentioned, "Are they going to be on one resolution?" His recommendation is to break it down, or each of the projects have its own resolution. We cannot try to do everything all at once. Aaron responded that this resolution is a statement of initiative, all of them are listed in the resolution so the intention of the community to support this initiative is identified. The Klagetoh community has to put the initiative out there so community members will support these initiatives. In addition, the support will also begin building a base to use for guidance toward declaring Klagetoh as a

township. After the resolution is passed, the community can later identify which initiative to pursue and at that time, can submit another resolution specifically related to the initiative

that the Klagetoh Community chose to pursue.

9. Maureen Woodman commented that this resolution is like a cover sheet for all the projects. When the money is identified, then another resolution can be presented where there is a plan of action for said projects. She commented that Capital Improvement Project proposals is nearing and it's time for new projects which need to be identified and we need to move forward with new projects and to incorporate new projects. Discussion ensued on changes forthcoming due to climate change.

- 10. Maggie Roanhorse commented that Aaron's ideas are good. He already has some of these projects in the CLUPC booklet manual. Why are we hashing all this up again? They gave us direction on what needs to be done for the old school compound. We need to stop talking about it and to act on it. She is not sure if Aaron is supposed be presiding over the land use plan as he declared his candidacy for president. Once they announce them position, they're supposed to step down from their position. Everything we do goes through the five-management system. We cannot just blindly move forward on projects as we follow procedures. He needs to come down to the community level so the community can understand what is being discussed.
- 11. Leland elaborated on the energy summit we attended. He was surprised of what the discussions were at this summit. By 2050 we will be a carbon neutral entity affecting the reservation roads, water line, incorporate solar into the chapter house renovation and other projects where necessary. On another note, there is a need for a waterline for the community who live on the east side of the community. Based on the community assessments, the community can identify the priority projects.
- VI. Guest Request made during review of the agenda
 - A. Alex Montoya, Tse Holtsoi Medical Center will do a report at the Regular Meeting.
 - B. Molly Big Knife stated that their resolution was recommended by Window Rock. The local government approval is needed to get a permit for data gathering for study. Resolutions are needed to move forward to agency level and Navajo Nation level for conducting the research. Molly Big Knife explained that her daughter Olathe Antonio will research the practice of how traditional people have lived off the land; how does a traditional lifestyle close to nature help people mentally and physically? Laverne Joe asked "is this individual going to be visiting house to house? I'm not sure, how the individual is going to gather data; maybe it's better to hold the
